**NOTICE - PLEASE READ:** Chico Municipal Code Sections 10.30.010 through 10.30.190 provide in part that preferential parking permit areas may be established for the purpose of limiting vehicle parking within such areas. No vehicles, other than emergency vehicles, vehicles providing service to the area, vehicles displaying a license plate or placard issued by California Department of Motor Vehicles to denote use by a disabled person, and vehicles which are registered to or under the control of and exclusively used by, persons residing or employed within the designated area, may stop, stand or park on any street within this area during the hours of 8 AM to 8 PM, Sunday through Saturday. By completing and signing this application form you will be certifying that the vehicle upon which your parking permit will be affixed meets the necessary requirements for use of the permit. Note: Your Preferential Parking Permit is only valid for the specific preferential parking area in which you reside and is not valid in any other preferential parking area.

| <b>III. REQUIREMENTS</b>  |
| <p>The permit must be <b>affixed</b> and displayed within a 7" square in the lower left corner of the <b>front</b> windshield (driver's side). Pursuant to Chico Municipal Code, the previous year's sticker <b>MUST</b> be removed before applying the new one. Only the current year's permit is to be on the vehicle described above. <b>If and when a vehicle is sold, the parking permit sticker MUST be removed from the vehicle and returned to the Finance Office. If you no longer live in the preferential parking permit area, you cannot continue to display the permit.</b></p> <p><b>WARNING!</b> Falsification or misrepresentation of any of the information supplied on the Application for Preferential Parking Permit above constitutes sufficient grounds for denial of the application or revocation of any permit which may be granted hereafter, and is considered to be an infraction which is punishable by fine. Further, violation of any prohibition on the use of a permit <b>shall be a misdemeanor punishable by imprisonment in the county jail for a period not exceeding six months, or by a fine not to exceed \$1,000.00, or both.</b></p> <p><b>REPLACEMENT:</b> To be made <b>ONLY</b> upon payment of the fee and <b>ONLY</b> when vehicle has been sold or transferred, in which case the sticker is to be removed from the vehicle and presented to the Finance Director to apply for a replacement.</p> |
